



PUBLIC VEHICLE AUCTION TERMS & CONDITIONS

Bidder Registration

All bidders must register before entering the auction yard and present a valid government-issued photo ID. A \$200 CASH bidder deposit is required upon entry to participate in the auction.

- If you win a vehicle, the \$200 deposit will be applied toward the purchase price.
- If you do not win a vehicle, the \$200 deposit will be refunded when exiting the premises.

Wilson Towing LLC reserves the right to refuse registration or participation to any individual at any time.

Deposits & Bidding

All bids are final and irrevocable. For any vehicle with a winning bid over \$2,000, a total deposit of \$500 CASH is required immediately. If the \$200 bidder deposit has already been paid, the bidder must provide the remaining \$300 immediately. Once a bid is accepted, it may not be withdrawn, canceled, or renegotiated. Failure to complete the purchase will result in forfeiture of all deposits and the vehicle may be offered to the next highest bidder or resold. In the event of a bidding dispute, the auctioneer's decision is final and Wilson Towing LLC reserves the right to reopen bidding or reoffer the vehicle.

Vehicle Condition

All vehicles are sold AS IS, WHERE IS, with no warranties or guarantees, expressed or implied. Wilson Towing LLC makes no representations regarding the condition, operability, mileage, completeness, or safety of any vehicle. Vehicles may contain mechanical damage, missing parts, electrical issues, or other unknown defects. Buyers are strongly encouraged to inspect vehicles prior to bidding. Wilson Towing LLC is not responsible for any defects, repairs, missing parts, or damages discovered after the sale.

Title & DMV Disclaimer

Vehicles are sold pursuant to California lien sale laws. Wilson Towing LLC does not guarantee the DMV will issue a title without additional requirements, including but not limited to VIN inspections, additional paperwork, registration fees, penalties, or back fees. The buyer assumes all responsibility for DMV title transfer and registration.

Certain vehicles sold pursuant to California Civil Code §3071 may be subject to statutory redemption periods and additional processing requirements. Buyers acknowledge that vehicles valued over \$4,000 may be subject to a 10-day post-sale redemption period during which ownership transfer and vehicle release may be delayed. Buyer assumes all risks associated with statutory lien sale procedures, redemption rights, title processing delays, and DMV requirements.

Payment & Vehicle Removal

All vehicles must be paid in full by 4:00 PM on the day of the auction. All vehicles must be removed from Wilson Towing's lot by 4:00 PM the following day. Vehicles not removed by the deadline may incur additional storage charges and may be subject to re-storage, reprocessing, or disposal at Wilson Towing LLC's discretion. Failure to complete payment or remove the vehicle will result in forfeiture of all deposits and payments made.



Auction Yard Rules

For the safety of all attendees:

- No repairs or removal of vehicle parts in the auction yard
- No tampering with vehicles prior to purchase
- No children or pets allowed on the premises
- Alcohol and drugs are strictly prohibited

This auction is for buyers only. Individuals who are not intending to purchase vehicles may be asked to leave. Any violation of these rules may result in immediate removal from the premises and forfeiture of bidder privileges.

Right to Refuse Service

Wilson Towing LLC reserves the right to refuse service, deny entry, remove individuals from the premises, or reject bids at any time for any reason, including disruptive behavior or failure to comply with auction rules.

Assumption of Risk & Liability Waiver

By entering Wilson Towing's premises, all bidders and visitors assume all risks associated with auction attendance, including potential injury or property damage. Participants agree to release and hold harmless Wilson Towing LLC, its employees, agents, and affiliates from any liability arising from presence on the property or participation in the auction. Participants further agree to indemnify and defend Wilson Towing LLC from any claims arising from their actions.

Photography, Video & Social Media Disclosure

Wilson Towing LLC may photograph, video record, livestream, or otherwise capture images and audio during the auction for advertising, marketing, promotional, training, security, or other lawful business purposes. By entering the premises or participating in the auction, attendees acknowledge that they may appear in such recordings and grant Wilson Towing LLC the irrevocable right to use, reproduce, publish, display, distribute, and edit their name, likeness, voice, image, and vehicle-related activities in any media now known or later developed, including websites, social media platforms, advertisements, and other promotional materials, without additional notice, compensation, or approval. Individuals who do not wish to be photographed or recorded should notify a Wilson Towing LLC representative prior to entering the auction area; however, Wilson Towing LLC cannot guarantee that incidental capture in photographs or video will not occur.
